Sub: Annual Assets and Liabilities statement for the
Year ending **2012** - reg.

All the Judicial Officers and Chief Administrative Officers/Assistant Registrars, working in subordinate courts are requested to submit their annual statement of Assets and Liabilities in the prescribed form for the year ending 31st December 2012.

Further, if there is no variation or change in the return furnished for the previous year and current year, the prescribed form need not be used, but they are required to declare in writing to the effect that the return furnished for the previous year holds good for the current year, alongwith the following particulars:-

24.	Salary/income of his/her wife/husband.	
25.	Cash on hand as on 31.12.2012.	
26.	<u>Liabilities (Debts):</u> i) Loans availed by the Officer or in the name of his/her family members from Banks, Financial Institutions, Co-operative Societies, etc., and the yearly amount repaid during the year towards such loans.
