- (iii) Synopsis of the case (Rule 2(3)(b) of WP Rules).
- (iv) Non-filing of affidavit/errors in Affidavit.
- (v) Non-filing of the impugned order.
- (vi) Objections regarding rank of parties/ non-joinder of necessary parties.
- (vii) Where Government/BBMP/BESCOM/ KIADB is party, service of copy on SP/GA/ASG/Standing Counsel/Panel Advocate.
- (1) Smt. B.V. Renukamma, Joint Registrar, (2) Smt. Anitha, Deputy Registrar (S.S.), (3) Smt. P. Kavitha, Deputy Registrar, and (4) Smt. Manjula R, Deputy Registrar, are hereby nominated to monitor and attend all the grievances regarding the auto-listing of cases.

All the concerned staff shall follow the directions scrupulously and any violation in this regard will be viewed seriously.
