Therefore, firms who are dealing with Manufacturing / Supplying of aforesaid Crockery, Electric & Other items located in Bengaluru, may submit their sealed quotations mentioning their lowest rates excluding GST & any other taxes, with the following Terms & Conditions.

1. The rates have to be quoted at Basic price (exclusive of GST and other taxes) and the said prices shall be inclusive of transportation charges. Rate agreement will be made with the successful firm. The rate once accepted by this office should not be increased till the expiry of the Agreement. The agreement shall be for a period of **“12 MONTHS”** from the date of execution of this agreement and will automatically expire after completion of one year or also procurement upto ₹5,00,000/-, whichever is earlier.
2. Supply should be made immediately even on non-working days, if directed by this office.
3. The payment will be made to the firm's Bank account, through Khajane-II Platform of Government of Karnataka as per the Bank details furnished by the firm.
4. The aforesaid Crockery & Electric items to be supplied by the supplier/vendor, at the standards sought by this office. If the materials supplied found damaged/not satisfactory, the same is liable to be rejected and payment due, if any, towards supply of such Crockery, Electric & Other items may be with-held till the same is replaced with new one.
5. The materials should also be supplied to the High Court, High Court Guest House at Nyayagrama, Hebbal, as and when directed.

6. Right is reserved by High Court of Karnataka to cancel the Agreement at any time, if the materials supplied are found to be not satisfactory or for breach of any of the conditions at Sl. Nos. 01 to 05 above.
7. Right is reserved by the High Court of Karnataka to accept / cancel any quotations without assigning any reason, outright.

The sealed quotation should be addressed to the Registrar General, High Court of Karnataka, Bengaluru – 560 001 and the same shall reach the Tappal Branch of this office on or before 24.01.2025 at 05.00 P.M. Any quotations received after the due date and time shall not be considered and rejected outright. The sealed cover containing the quotation should be superscribed with **“QUOTATION FOR SUPPLY OF CROCKERY, ELECTRIC & OTHER ITEMS”**.

The quotations will be opened on 25.01.2025 at 12.00 noon in the Chambers of Registrar (Administration), High Court of Karnataka, Bengaluru.
