5. Applicant shall enter the name as mentioned in the **X Std./SSLC** marks card. [SI.No.1, Maximum characters - 50].

- 6. Applicant shall enter his/her Father name as appearing in the **X Std./SSLC** marks card. **[SI.No.2, Maximum characters 50].**
- 7. Select the appropriate Gender of the Applicant i.e. Male/ Female/ Others (transgender) by selecting corresponding Radio Button **[SI.No.3].** If applicant select Others (transgender), specify sub gender Male/Female.

11. Applicant shall indicate his/her Marital Status as "Married" or "Unmarried". If married, select the appropriate sub selection as "Divorced", "Widowed", "Judicially Separated", "Bigamous", "One Spouse" **[SI.No.7].**

12. Applicant shall select the appropriate Citizenship [SI.No.8].

- 13. Applicant shall mention his/her annual income [SI.No.9].
- 14. Contact Information [SI.No.10].
 - a. Applicant shall mention his/her Present address including the Door number, Street, Place, Area, Taluka, District and State with Pin code.

Note: If Permanent address is same as Present address, then select "**Yes**".

b. If permanent address is different, applicant shall mention his/her Permanent address including the Door number, Street, Place, Area, Taluka, District and State with Pin code.

15. Applicant shall enter valid Mobile number (**Mandatory**), Landline number. The authority is not responsible for non receipt of communication by **SMS**, if the mobile number furnished is wrong. **[SI.No.11(a) (b)].**

16. Applicant shall enter his/her **E-mail ID (Mandatory)** [**Sl.No.12**]. The authority is not responsible for non receipt of communication, if the Email ID furnished is wrong.

17. **Enrolment Information** - Applicant shall mention his/her Enrolment details including the Enrolment Number, Year, Date of Enrolment, Date of Commencement of Practice, Place of Practice, Nature of Practice **[Sl.No.13]**.

18. Applicant shall select "Yes" or "No" radio button for mentioning whether the applicant is a practicing Advocate. [**SI.No.14].** If yes, then applicant shall select "High Court or District Judiciary", as practicing in as on the date of application.

19, In-service candidates shall mention 'Yes' or 'No' while submitting online application and if the candidate is selected, he/she shall produce "No Objection Certificate" from the concerned department, where he/she is working as per amended Rule 11 of Karnataka Civil Service (General Recruitment) Rules, 1977. [SI.No.15].

20. Applicant shall select "Yes" or "No" radio button for mentioning whether there is any Enquiry Pending/contemplated against the Applicant before Government Department/Bar Council/any other authority. [Sl.No.16, Maximum - 80 characters].

21.Applicant shall select "Yes" or "No" radio button for mentioning whether the applicant had earlier applied for the post of Civil Judge or any other Judicial post. If "Yes", then applicant shall enter the details [SI.No.17, Maximum - 80 characters].

22. Applicant shall mention details as to whether the applicant is/was involved in any Civil/Criminal/Quasi Judicial Proceedings in any capacity. If Yes, give details **[Sl.No.18, Maximum - 150 characters].**

23. If applicant is married, shall mention his/her spouse was/is involved in any Civil/Criminal/Quasi Judicial Proceedings in any capacity. If Yes, give details **[Sl.No.19, Maximum - 150 characters].**





Photo and Signature Upload Guidelines for scanning and Upload of Photograph and Signature File Upload Use Browse 'Mozilla FireFox 16'/'Google chrome 10' and higher version, Please Note 'Internet Explorer' does not support to upload Photograph Image (JPG Format). a. Photograph must be a recent passport style colour picture. b. Make sure that the picture is in colour, taken against a light-coloured, preferably white, background. c. Look straight at the camera with a relaxed face. d. If the picture is taken on a sunny day, have the sun behind you, or place yourself in the shade, so that you are not squinting and there are no harsh shadows e. If you have to use flash, ensure there's no 'red-eye' f. If you wear glasses make sure that there are no reflections and your eyes can be clearly seen. g. Caps, hats and dark glasses are not acceptable. Religious headwear is allowed but it must not cover your face. h. Allowed Photo Size � 3.5 cm x 5 cm and stored in (*.jpg) format on local machine only. White Background i.Size of file should be between 25kb-50kb 3.6 cm j. Ensure that the size of the scanned image is not more than 50KB. If the size of the file is more than 50 KB, then adjust the settings of the scanner such as the DPI resolution, no. of colours etc., during the process of scanning.
