# **CONDITIONS**

1. The candidates shall be on probation initially for a period of 2 years from the date of entry into service in accordance with Rule 9 of the High Court of Karnataka Service (Conditions of Service and Recruitment) Rules, 1973, as amended from time to time.

- 2. The candidates are liable to be posted to work at High Court of Karnataka, Principal Bench at Bengaluru or any of the High Court Benches at Dharwad or Kalaburagi.
- 3. The inter-se seniority between the selected candidates will be in accordance with their ranking in the final selection list.
- 4. The candidates at the time of their reporting to duty for appointment are required to execute a bond on a Stamp Paper (non-judicial) with an undertaking that they will serve in the office of the High Court of Karnataka for a minimum period of 5 years, failing which they will be liable to pay Rs. 50,000/-.
- 5. The candidates shall report for duty within 15 days from the date of order of appointment; failing which, their names shall stand deleted from the list of selected candidates and the candidate concerned shall cease to be eligible for appointment, as per Sub-Rule 3 of 18 of the Karnataka Civil Services (General Recruitment) Rules, 1977.
