The candidates as per Annexure are successful in the Shorthand and Typing Test held on 19.02.2023 and are eligible to appear for viva-voce for Direct Recruitment of 54 posts of Assistant Court Secretary (i.e., 44 posts under Residual Parent Cadre and 10 posts under Local Cadre) on the Establishment of High Court of Karnataka.

The viva-voce will be conducted on 17th and 18th March 2023, at Principal Bench, High Court of Karnataka, Bengaluru. The intimation letters for viva-voce will be uploaded on the official website of the High Court of Karnataka shortly and the candidates are requested to download the same and follow the instructions issued therein.

Further, the candidates eligible for viva-voce are required to produce **Intimation Letter** along with the following **Original Certificates/Documents Compulsorily and one set of self attested Copies of said Certificates/Documents** during the time of viva-voce for verification:

1. S.S.L.C or Equivalent Marks Card for proof of Date of Birth and Identity Card (Aadhaar Card / Voter ID / Driving Licence) for address proof.

2. (a) English Senior Grade Typing Certificate or
(b) Diploma in Commercial Practice / Secretarial Practice i.e., I to VI Semester / I to III year, Convocation Certificate,
(c) Certificate of Senior Grade/Proficiency Grade Examination in English Shorthand,
(as the case may be)
3. If claiming reservation under Scheduled Caste /Scheduled Tribe /Category - I / II(A)/ II(B)/ III(A)/ III(B) / Kannada Medium Student / Rural Certificate for having studied from I to X Standard / Ex-servicemen/ Persons with Benchmark Disability / Persons Displaced from Project / Local Cadre (Eligibility Certificate under Article 371-J of the Constitution of India - Hyderabad-Karnataka Region - in *Annexure - A*) certificates obtained from the competent authorities which are issued within the stipulated period i.e., as on the last date of the fixed for applying to the post i e., 07.04.2022.
4. Certificate in Computer Basics issued by an Institute imparting Computer Education.
5. Three Character Certificates i.e., *One from the Principal of the Institution/College in which you have last studied with study details and Two from Respectable Persons not being your relative but who is well acquainted with you.*

NOTE: 1. Candidates who fail to produce the **Original Certificates/Documents along with One Set of Attested Copies of Documents** on the date of viva-voce are liable to be disqualified.

2. The candidates are requested to enter the High Court premises from Gate No.3 (i.e., near High Court Security Office) and report at Court Hall No.38, Ground Floor well in advance.
