- b) Degree, Law Degree Certificates, Marks Cards, Convocation Certificate.
- c) Enrolment Certificate issued by Bar Council and Sannad.
- d) Certificates obtained within the stipulated period from the competent authorities, if you are claiming reservation under SC/ST/Cat-I/ IIA/ IIB/IIIA/IIIB/Kannada Medium/ Rural/ Ex-Servicemen/ Physically Challenged.
- e) Two Character Certificates of good character one from the Principal of the Institution/College in which you have last studied with study details and another from a respectable person not being your relative but who is well acquainted with you.
- f) Creamy Layer Certificate, if you are claiming reservation under General Merit (Rural) category.
- g) Practice Certificate from the concerned Bar Association, if the candidate practiced or is presently practicing as an Advocate.
