- 6. Relevant Experience Certificate as notified in Notification No. HCRB 12/2022 dated 16.06.2023,
- 7. Caste and Income Certificate, if any,



- 8. Three character certificates i.e.,
 - a) One from the Head of the Institution from where the ITI course completed with study details

and

b) Two certificates of recent origin from respectable persons in the society who are well acquainted with the candidate but not being relative of the candidate.

<u>Note:</u> 1. The candidates are instructed to produce all relevant Original Certificates and submit one set of self attested copies on the date of Interview without fail.

- 2. All relevant certificates must have been obtained prior to the last date of submission of online application.
- 3. The candidates are **instructed to report at 9.00 a.m., on 29.01.2024** at Court Hall No.36, Ground Floor of High Court of Karnataka, Bengaluru by entering the High Court premises from Gate No.3, Near High Court Security Office.
- 4. The document verification of the candidates will be done in Morning session and Interview will be held in afternoon session.
