1. Identity proof (Aadhaar Card / Voter ID / Driving Licence/ KSBC ID Card) for address proof,
2. S.S.L.C or Equivalent Marks Card for proof of Date of Birth,
3. All Semester LL.B Marks Card/Convocation Certificate,
4. Certificates of Additional qualification if any,
5. Enrolment Certificate in Karnataka State Bar Council,
6. Computer Course Certificate, if any,
7. Achievements in LL.B and Co-curricular activities as mentioned in the application, if any.

NOTE: The candidates are requested to enter the High Court premises from Gate No.3 (Near High Court Security Wing) and report at Court Hall No.35, Ground Floor well in advance.
