I N T I M A T I O N

This office vide intimation dated 10.12.2021 has shortlisted 997 candidates in the ratio of 1:7 (only for verification of documents) in the order of merit in each of the respective categories (both in Residual Parent Cadre and Local Cadre) for filling up 142 posts of Second Division Assistant (127 posts under Residual Parent Cadre and 15 posts under Local Cadre) in pursuance to this office Notification No.HCRB/SDA-5/2021 dated 24.08.2021, and directed the candidates to produce original testimonials/documents and to submit one set of self attested copies of documents in respect of the claims which are relied upon by them at the time of submission of online application, either personally or through authorized person from 13.12.2021 to 23.12.2021.

Further, after verification of the documents submitted by the candidates, it is found that there is shortfall of candidates under some categories to shortlist the candidates for competitive test at the ratio of 1:5. Therefore, following additional candidates are shortlisted in the ratio of 1:7 (only for verification of documents) in the order of merit in the categories where there is shortfall.
