On Vacation Court sitting days, papers will be received from 10.00 AM to 3.30 PM. E-filing shall also be permitted through E-filing portal.

Motions to take up pending case/s shall be made before the respective Benches on the Vacation Sitting Day narrating the urgency by filing a memo.

Vakalathnama, Process Fee and Process memos in all pending matters will be received in the respective counters in the Principal Bench at Bengaluru and Benches at Dharwad and Kalaburagi during Vacation between 10.00 AM to 12.30 PM, except on Vacation Court sitting days. On Vacation Court sitting day, papers will be received from 10.00 AM to 3.30 PM.
